

INVITATION FOR BIDS

SUPPLY AND DELIVERY OF 4500 TABLET DEVICES FOR UNSERVED AND UNDERSERVED HOUSEHOLDS IN 23 DISTRICTS IN UGANDA

- 1. The Uganda Communications Commission (UCC) has allocated funds under the Uganda Communications Commission Universal Service and Access Fund (UCUSAF) to be used for increased public access to Information and Communications Technology (ICT) services.
- 2. The Uganda Communications Commission now invites sealed bids from eligible bidders for Supply and Delivery of 4500 Tablet Devices for Unserved and Underserved Households in 23 Districts in Uganda.
- 3. Bidding will be conducted in accordance with the Open Domestic Bidding, a procedure contained in the Government of Uganda's Public Procurement and Disposal of Public Assets Act, 2003 and is open to all bidders.
- 4. Interested bidders may obtain further information and inspect bidding documents from Uganda Communications Commission at the address given below at 8(a) from 8:30 hours to 17:00 hours during working days.
- 5. The Bidding Documents in English Language may be purchased by interested bidders on the submission of a written application to the address below at 8(b) and upon payment of a non-refundable fee of **UGX.100,000/=** (**Uganda Shillings one hundred thousand only).** The method of payment will be to a bank account of Uganda Communications Commission at Stanbic Bank Uganda Limited, Corporate Branch, Crested Towers, Kampala; UGX.A/C No. **9030005759004.**
- 6. Bids must be delivered to the physical address below at 8(c) at or before 4th December 2024. Bids shall be accompanied by a bid security of UGX 30,000,000 (Uganda shillings thirty million). Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 8(d) at 10:15 am on 4th December 2024.
- 7. There shall be a virtual pre-bid meeting on 21st November 2024, 11:00am. A link for the meeting will be shared a day before.
