- 1. The Uganda Communications Commission (UCC) has allocated funds under the Uganda Communications Commission Universal Service and Access Fund (UCUSAF) to be used for increased public access to Information and Communications Technology (ICT) services.
- 2. The Uganda Communications Commission invites sealed bids from eligible bidders for requirements for Provision of Services for Digital Literacy Training and Distribution of 4500 Tablet Devices to Households In 23 Districts.
- 3. Bidding will be conducted in accordance with the Open Domestic Bidding, a procedure contained in the Government of Uganda's Public Procurement and Disposal of Public Assets Act, 2003 and is open to all bidders.
