1. The Uganda Communications Commission (UCC) has allocated funds to enhance spectrum monitoring coverage and intends to procure and deploy additional spectrum monitoring systems in Soroti and Fort Portal districts.
2. The Uganda Communications Commission invites sealed bids from eligible bidders for Supply, Delivery & Installation of Frequency Spectrum Monitoring System for Fort portal & Soroti.
3. Bidding will be conducted in accordance with the Open International Bidding a procedure contained in the Government of Uganda's Public Procurement and Disposal of Public Assets Act, 2003 as amended and is open to all bidders.
